VII. New Business

Faculty Hiring Prioritization for 2025/2026 --90 min (I/A)
 Senate President Joanna Sobala welcomed Senate and guests to the faculty hiring prioritization session for AY 25-26. Senate reviewed 13 applications and after short presentations from Departments that applied for faculty hiring, met with division representatives to rank faculty applications. The College so far is considering 2 to 4 faculty positions to go forward. Each Department presentation was limited to 3-5 minute including answering any questions.



Kelly Neary – Biology, Environmental Science Emphasis

- Request for faculty replacement. Jean Replicon is retiring SP25.
- Associate Faculty prior member Phil Higgins taught Bio 25, Environmental Studies, later taught by FT faculty who is not an environmental expert.
- Environmental Science AS-T with prescribed courses went through pipeline quickly last year.
- A new Climate Science degree would need a climatologist to develop coursework.
 - o Labor market 7% growth in the next 10 years
 - o UCs beginning to require a course in environmental science

Guy Hall – Fire Protection Technology [#1, #2]

- In one year, students can get EMT and Firefighter One that qualifies for a job as a firefighter
- AS degree can be completed while working
- B.S. Degree just approved by State, looking at faculty positions
 - Replacement for Dave Rose (retiring SP25 EMT Director)
 - FT position for B.S. Degree and focus on Academy Course(s) and partnering with local Fire Agencies to run their Fire Academies
- Statistics: Fill rate exceeds 90%, 2023-24, high efficiency rate, and FTEF is 7.35
 - Want to increase percentage of FT faculty relative to PT faculty

RaeAnn Ramsey – FT Ethnic Studies

- AB1460 mandate to bring in someone with Ethnic Studies credentials.
- Requesting a new FT Ethnic Studies faculty member.
 - o Currently 2 courses approved, over 98% fill rates and very high success rates.
 - o MC new curriculum is now written and courses should be offered by Fall25.
 - All MC 6,000 students have to take an Ethnic Studies course to graduate and is required in any sort of Humanities, History, PoliSci AA, AT, or at UCs and CSUs.
 - o Current Faculty, one qualified PT Faculty teaches one course and second PT instructor just added.
 - State requires Instructor to have an Ethnic Studies Degree. Only one PT instructor who teaches online has that degree.
 - o More in-person courses can start with a new, designated FT instructor.
 - Required for accreditation.
 - o MC students are being referred to WV and California Virtual as MC Ethnic Studies courses are full.

Pedro Sousa, Sarah Sullivan, Lorrie Ranck – Professional Learning Faculty Lead

- Non-Instructional position. New dedicated position.
 - Professional development is broken up into three areas: Staff improvement, Student improvement and Instructional improvement.
 - o Have advocated for this FT Faculty Coordinator since 2019.
 - Directly connected to student learning and success across the college.
 - Innovative teaching led by one faculty member, coordinating all the faculty learning efforts.



- Professional Learning subcommittee with members from all sectors of college unanimously supports this FT position.
- Opportunities to develop virtual landscape, physical spaces, the Library, onboarding, and creating a culture that is a wraparound service embracing Professional Development and Equity.
- Other institutions offer this support for faculty across their colleges with a central faculty member to help build community.

Alicia Martinez and Veronica Hand – Puente Counselor (50%) / General Counseling (50%)

- Request for FT replacement position. Counseling Dept has lost 2 FT positions the last 2 years as enrollment grew.
 - Counseling Dept operates year round.
 - o Student demand has increased, counseling services waitlists are too long.
 - Appointments often have one month waits to write E Plan or talk for half an hour.
 - Counselors in January and summer may only have 5-15 minutes to support students registering for classes. Special programs counselors are not here in winter and summer when offices are closed.
 - Puente (10-year program) is a transfer preparation and learning community that empowers our Latinx (33% of Mission students) and first-generation population of students. Puente Counselor Nohemy Chavez left MC in Fall 22. Veronica Hand who filled in for Nohemy is rotating back to General Counselor.

Lania Williams presented for Pharmacy Technician (PHT)/Director

- FT Faculty position as Pharmacy Technician New Position
 - o Dedicated professional to meet the license requirement of Pharmacy Tech Certification Board
 - Quality assurance and Admission process
 - o Continuous curriculum updates and new technology practices to fit the industry
 - o Build relationships with local pharmacists and industry, and employment opportunities
 - Current faculty are all PT and in need of FT
 - Transitioned to non credit with more opportunities for students to go into pharmaceutical industry
 - Only have current capacity to accept 25 students out of the 60 students that applied and want to meet increasing demand in this region
 - Teaching (.2 release time) is part of regulations and someone who has director qualifications to validate that students progressed in program

MOTION to extend time four minutes. (T. Lawhead/B. Wundram) (M/S/U) None opposed. No abstentions. Unanimous.

Director is needed to meet PHT certification requirement and regulatory obligation to our students as required by the State of California in teaching and in directing program. Part-time instructor is not preferred by the State of California.



Lania Williams – Health Occupations Nursing Dept [#1, #2]

Several of our most experienced, institutionally knowledgeable, longtime Faculty are retiring out and Nursing is asking to replace two FT faculty members. Currently have 7 faculty after filling last year's approved replacement. We have 3 RN cohorts of nursing students running concurrently with new applicants each fall, spring and fall, 40 to 45 and up to 60 with 15-20 high school students in the summer. Newbie faculty are overworked.

- Nursing Board Marcia Oliver is stepping down, Alicia Cruz, VN has to step in at .6.
- Some Associate Faculty are utilized at 15% higher than FT and in the clinical setting. Students are not getting the consistent faculty that is important.
- 100 applicants in October, can only take one-third.
- Nursing Assistant program is similarly in demand.
- Nursing is in transition and needs the full staff to offset our FTEF.
- RN, LVN, NA students have a high passing rate and we're going to 3 semesters and enrollment is growing.
- Faculty expertise and disciplines vary in the RN, LVN, NA programs.
- Competing with hospitals for our faculty.
- Accreditation next year.

Kaitlin Ferguson – Kinesiology [#1, #2]

Request for 2 FT faculty positions replacements (SP24 and SP25 also on medical leave this year)
Only 1 FT faculty that can teach all of the KIN classes. Fitness and Health Certificate was launched. As Chair, teaches 7 classes this semester and is responsible for the evaluations. WV PT faculty who are also coaches teach some classes but now have competing teams on the same campus.

- 8.2 FTEF Spring25 with one KIN FT member, down from 10 FT, and 15 PT. Everyone has to be evaluated.
- Serve 888 students, cohort of courses that have to be offered.
- Everyone has to be evaluated. This year, 15 evaluations.
- Certificate program.

Willy Kwong – Child Development

Child Development Dept can do much more to meet dept needs and challenges.

- Focused on offering more in-person classes based on enrollment trends, 55% growth from F22-F24
- 24 CHD sections are supported by 3 FT faculty members
- Waitlists already for SP25
- Completion rates: Latinx 49%, high success (74%) and retention rates (85.5%)
- Don't have a lot of Latinx faculty



- Asian faculty are top 2 members in CHD Dept with Asian students high success (87.9%) and retention rates (92.9%)
- SP25 offering a CHD class taught in Spanish, not taught in many other California colleges

MOTION to extend time three minutes. (R. Ramsey/T. Lawhead) (M/S/U) None opposed. No abstentions. Unanimous.

- o Can say want a Spanish speaker to support community in this position
- o Serving East San Jose, San Jose Public Library, Title 5 agencies, and population outside our service area.
- We want our partnerships to stay strong
- Have brought in \$500,000 for the College with about \$50k per class. Some of the funds are used for other services on campus.

Daniel Arias, Hospitality Management

Building future program leadership and direction. Reduced from 3 to 2 FT Faculty in 2023, FT 47%, Adjunct 53%. HM is a very complex dept with many different disciplines: accounting and business, math, equipment maintenance, safety and health, and cooking and menus, work experience, and future education programs.

MOTION to extend time three minutes. (B. Wundram/R. Ramsey) (M/S/U) None opposed. No abstentions. Unanimous.

- Programs are HM Certificate and AS Degree and the same for Pastry and Culinary Arts.
 4.5 FTEF per semester with an annual allotment of 10. With 3 FT faculty we'd have room to offer adjunct classes. FT faculty teaches the research class with about .8 load.
- Elmwood: Director Haze Denis and Daniel Arias teach classes and one PT faculty teaching a lab class (50% extra time than campus) and a PT faculty teaching a lecture class (30% more time than campus).
- o Enrollment has increased over 4 years.
- o MC Bistro
- Student and Campus events up to 2-4 Caterings weekly in the past
